The matter regarding enhancement of TA/DA to
members of the Board of Directors of the Coop. Institutions
has been ~~not~~ under consideration for some time past.

It has been decided that TA/DA to be paid to non-
official members other than MLAs/MPs of Board of Directors
of the Coop. Institutions will be regulated as under :-

- a) No TA / DA or sitting fee shall be admissible to
Committee members of the Primary Credit/non Credit
Societies for attending meetings or visiting the
Society for any purpose.
- b) TA/DA and sitting fee shall only be admissible to
the members of the Managing Committee when the
members attend meetings of the institution or
visit them for which written requisition is sent
to them.
- c) TA/DA for study tours and other official purpose
outside the State of Haryana and Chandigarh will

be admissible when the study tour is conducted with the permission of the Managing Committee/ and prior approval of the Registrar.

- d) TA/DA shall be admissible to the Chairman of the Apex Institutions once in a fortnight and the Chairman/ Presidents of other institutions once in a month in addition to the visits made for meeting purposes.
- e) Travelling allowance shall be calculated either from the native place of the member or from the place from where he actually starts journey which ever is shorter to the place of meeting/ visit. The distance shall be recorded by the shortest rail/road route more often used by the public.
- f) Each member shall certify on each T.A. bill that no T.A./D.A. has been claimed from any other source for the same journeys and days for which TA/DA is claimed, from the Institution.
- g) A member shall be entitled to claim TA/DA only for the day(s) of meeting/visit, if the place of meeting/visit falls within 125 K.Ms from the place of start of journey/native place meaning thereby that no daily allowance for the journey day other than the meeting/visit day shall be allowed.
- h) A member travelling from a place of more than 125 K.Ms shall be entitled to daily allowance for incoming and outgoing journey days in addition to daily allowance for the day(s) of meeting/visit provided the journeys are actually undertaken on the previous following day of the meeting/visit.

1) The members when deputed to attend meetings of other Institutions/organisations to represent their institution shall claim TA/DA from the institutions/organisation holding the meeting, at the rates applicable to that institution/organisation.

2) The Cooperative Institutions are classified in the following three groups for grant of TA/DA and sitting fees:-

8. The members of the Central Coop. Consumers Stores Ltd. shall be entitled to draw their daily allowances at the rate of Rs. 5/- per day. The same may also be paid in cash to be received by the members on presentation of the receipt to the concerned Central Coop. Consumers Stores Ltd.

i) Group-A Rs. 120 per Day 60 200

ii) Group-B Rs. 100 per day 60 160

iii) Group-C Rs. 80 per day 100 130

2(b) In the case of travel by Institution Vehicle, half/full daily allowance shall be admissible for a period of absence as mentioned below:-

i) Where absence from Headquarter is for less than 6 hours; No daily allowance.

ii) Where absence from Headquarter is for 6 Hours or more but less than 12 hours; Half daily allowance.

iii) Where absence is for more than 12 hours but less than 24 hours; Full daily allowance.

3. The members including Presidents/Chairmen while on tour outside Haryana State and Chandigarh, will be entitled for reimbursement of actual lodging expenses duly supported with the actual payee receipt subject to maximum of Rs. 150/- per night.

4. Member of Cooperative Institutions shall be entitled to claim actual expenditure incurred by them on the purchase of single bus/rail ticket by the shortest road/rail route.

5. For the journeys from their native place to nearest Bus Stand/railway station or from bus stand/railway station to the place of official engagement/stay or vice versa, the members shall be entitled to flat rate of Rs. 2/- per K.M. with in and outside of the Haryana State.

6. The members travelling by conveyance for which nothing has been paid by them shall not be entitled to draw

the mileage etc. from the institution.

7. Members of all the institutions may claim TA for the Station, whether station is connected by Rail/Road or boat, a member who travels in his own Car/Jeep within the Station of Haryana, Chandigarh and Delhi shall be entitled to mileage as per Govt. instructions. The claimant member will certify that he has travelled by his own Car/Jeep giving registration No. of the Car/Jeep which registered in his own name or in the name of his wife, son and father.
8. Services of the members, shall be honorary, pay and type of remuneration, honorarium house rent or any other type of allowance shall not be admissible to them.
9. These instructions will come into force with immediate effect.
